Human Resources - Clarification of Employees sick Leave status

Superintendent Carroll explained that staff members receive one day of sick leave per employed month accrued upfront at the beginning of each school year. Upon retirement, the number of days accrued is factored into PERS or STRS.

STUDY & INFORMATION

Facilities - Continuing discussion regarding facilities planning

At the 9/28/2015 Board retreat, Board members, with the assistance of a facilitator, worked to establish a shared vision and project list for the District in regards to facilities. Notes from the Retreat were made available to Trustees. Superintendent posed the question: What should we do with the project list and do we want to proceed with a bond?

Discussion from the Board included:

- -concerned about new construction when there is a potential for rising sea level; would the County of Marin support new construction
- -concerned about community support for a gym/multi-purpose/performing arts facility
- -could a gym be constructed at Mesa Park; would Stinson residents support
- -feels that students do not need a gym
- -Why replace a building that is still usable; could the Quesada building be remodeled for a performing arts facility; review plans from architect in Inverness
- -what is the district's plan for a district sponsored pre-school
- -in planning, the district should look at programs first then at the facilities to support the programs.
- -if the board is not unanimous on proceeding with a GO bond, is it worth pursuing? What is the level of support from the communities
- -use bond monies for the agreed upon list (ADA compliance, Admin Building remodel, Art Space/Upgrade/enlarge, covered eating spaces, seismic safety/upgrades, kitchen upgrades, science lab/maker space, Stinson office/kitchen upgrades) then use existing funds or funds from other sources to fund gym/multi-purpose room.
- -add District pre-school program to the project list for the bond measure
- -if the district goes forward with a Bond, language must be clear and specific
- -the size of the multi-purpose room at the Nicasio school would be a good size for Bolinas-Stinson
- -is there a policy that determines when a class is combined
- -in a previous model, people felt rushed; in future plans have multiple options that cab be used to gauge interest and support and assign dollar amounts to them
- -goal should be the vision, not the election
